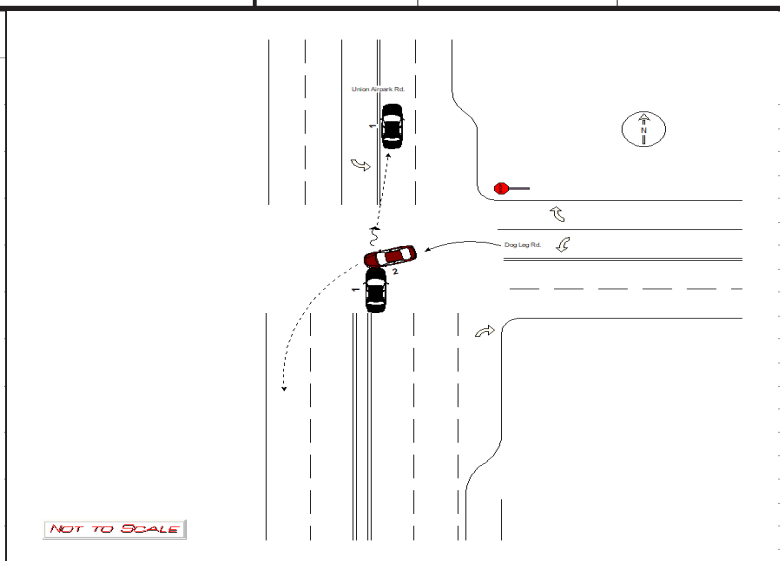

When Unit 1, traveling north on Union Airpark/Dog Leg Rd., in the left lane struck Unit 2. Unit 1 then fled from the accident and has not been identified.

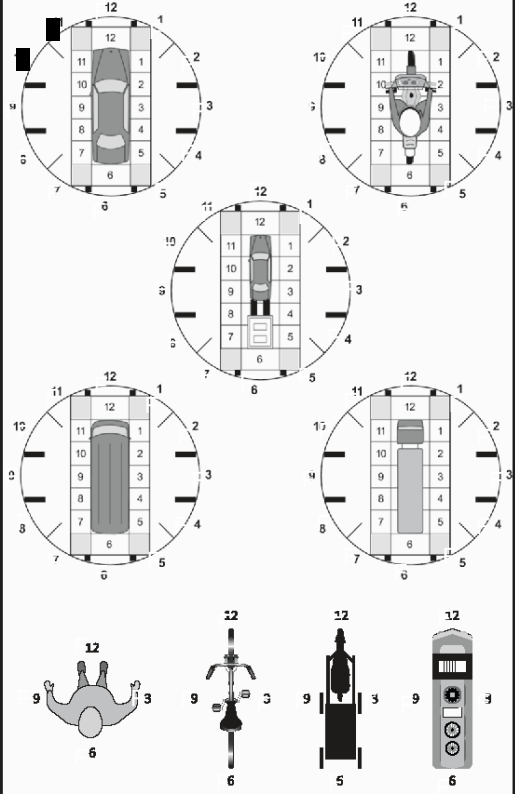

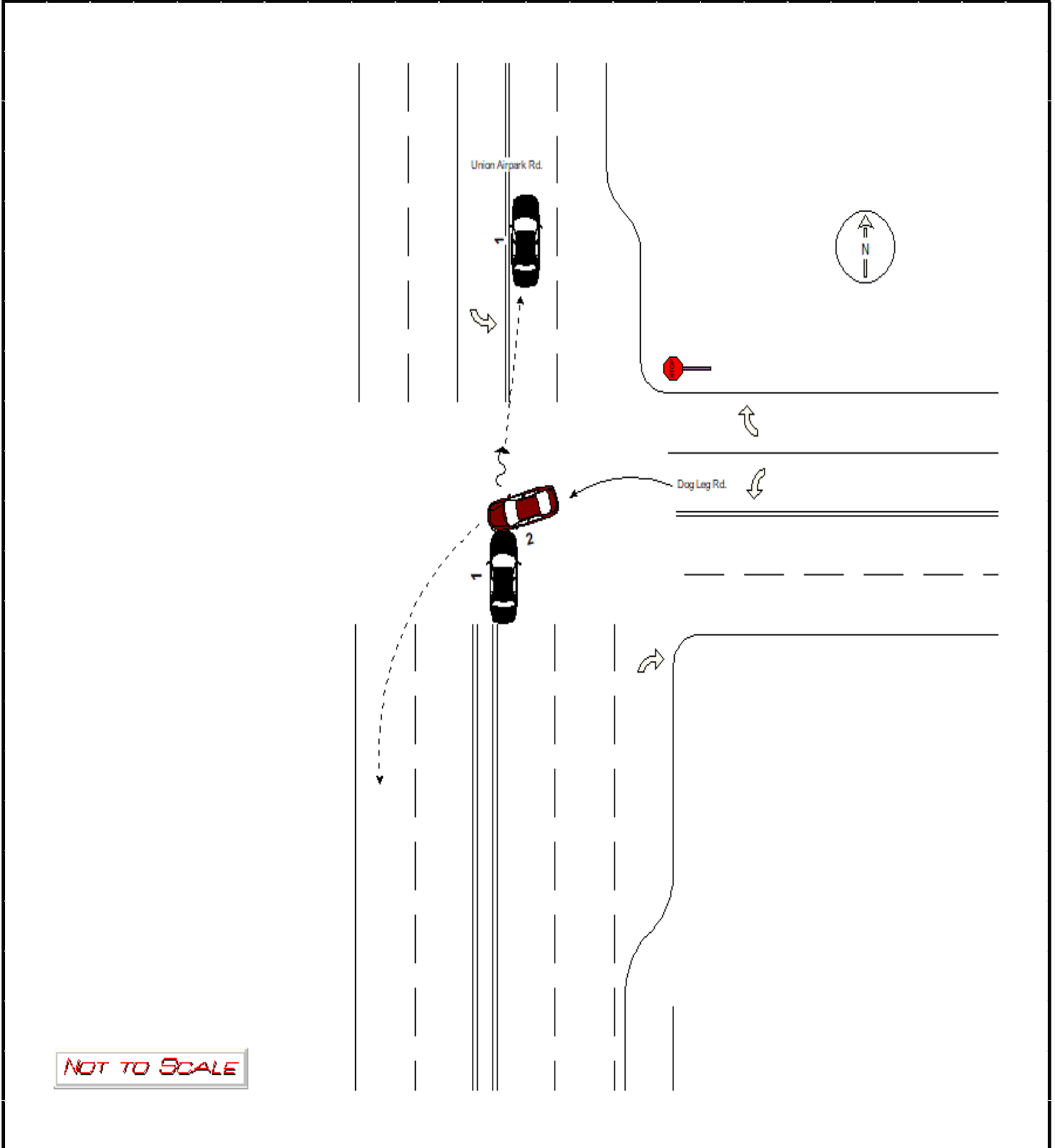
