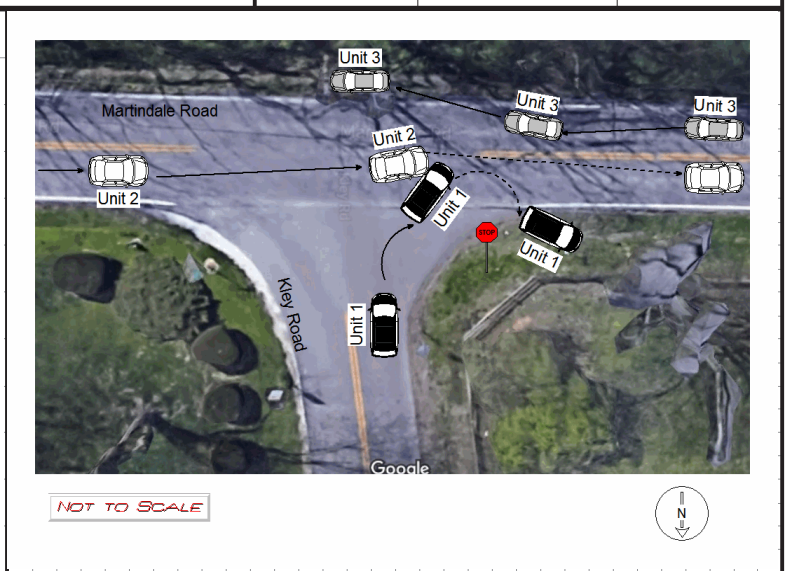

NARRATIVE

Unit #1 was traveling south on Kley Road and after having made the required safety stop at Martindale Road, proceeded into the intersection to turn right and continue west, and in so doing, failed to yield the right of way and collided with Unit #2 which was traveling west on Martindale Road in the west bound lane. This action caused Unit #3 who was traveling east on Martindale Road, in the east bound lane of travel to swerve to the right to avoid a head on collision, forcing Unit #3 into the right culvert, colliding with a Utility Pole #60333.

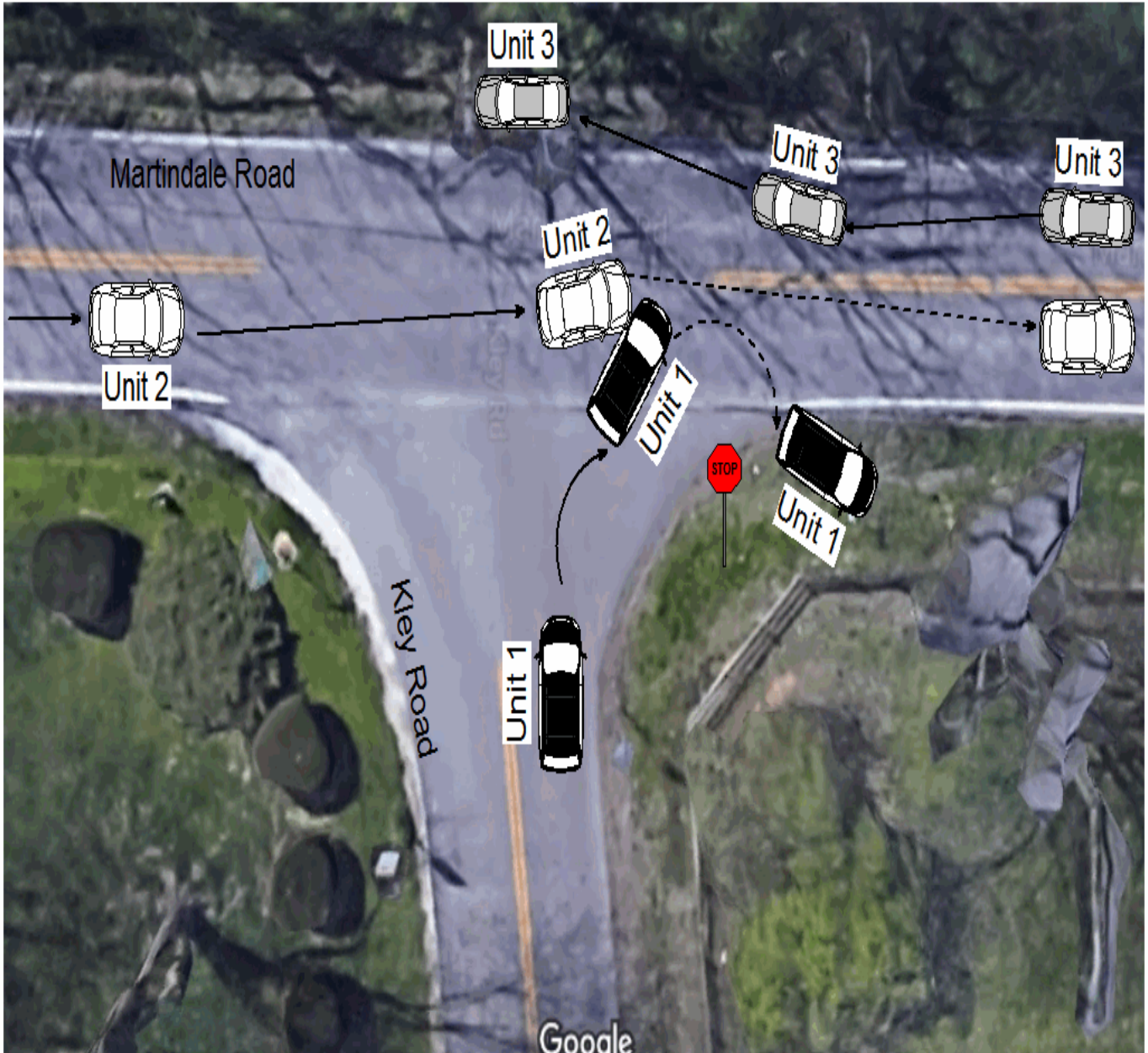

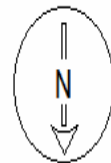
